MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES WESTERN WASHINGTON STATE COLLEGE August 8, 1968

The regular meeting of the Board of Trustees of Western Washington State College was held at 5:00 p.m., August 8, 1968, in 131 Education Building on the campus of the College in the City of Bellingham, Whatcom County, Washington. Present were:

Board members Joseph Pemberton and David Sprague did not attend the meeting. In the absence of the Chairman, Mr. Sprague, Mrs. Bernice Hall, Vice Chairman, chaired the meeting.

APPROVAL OF MINUTES OF MEETINGS

Mr. Kingsbury moved that the minutes of the meetings of June 29 and July 11 be approved; Mr. Philbrick seconded the motion; the motion passed.

67-16(A) HIDDEN VALLEY, PHASE 1 (Fairhaven College) CONSIDERATION OF BONDS AND AWARD OF CONTRACT

Mr. Goltz reported to the Board that the apparent low bidder on this project was Wick Construction Company of Seattle at a bid of \$3,647,000, which proves to be somewhat over the maximum allowable construction cost. Mr. Goltz recommended that a number of deductive alternates could be taken that would reduce this amount in order to stay within the \$4,819,800 previously authorized by the Board. Mr. Goltz recommended the following motion:

Upon the recommendation of the Project Architect and the Administration, and with the concurrence of the Field Engineer for the Department of Health, Education, and Welfare and the Division of Engineering & Architecture, the Board of Trustees accepts the low bid of Wick Construction Company of Seattle in the amount of \$3,647,000 and the following deductive alternates:

making a total initial contract amount of \$3,475,800 and requests the Division of Engineering & Architecture to issue the contract and Notice to Proceed on behalf of the College for Project #67-16(A) Fairhaven College, State Job #66-445. Mr. Kingsbury moved approval of the recommendation; Mr. Philbrick seconded the motion; the motion passed.

ACTION ON BIDS FOR PURCHASE OF HOUSING AND DINING SYSTEM BONDS OF 1968 AND RELATED MATTERS

Mr. Nusbaum announced that he had prepared a Notice of Sale of the Western Washington State College Housing and Dining System Bonds of 1968 and caused it to be published in The Daily **Bo**nd Buyer, published in the City of New York, New York, and in The Daily Journal of Commerce, published in the City of Seattle, Washington, as directed by Resolution No.68-5. Affidavits of

publication showing that such notice was duly published in each of said papers

on July 23, 1968, were submitted to the Board and ordered filed in the records

of the College.

Mr. Nusbaum also announced that he had prepared an Official Notice of Sale of said bonds and an Official Statement with regard thereto which he caused to be printed and distributed to prospective purchasers of the bonds and other interested parties, as directed by Resolution No. 68-5. Copies of such printed Official Statement, containing the Official Notice of Sale, were submitted to and examined by the members of the Board of Trustees. A copy thereof, signed by Mr. Kingsbury as Secretary, was filed with the Board. Mr. Nusbaum reported that all of the bids received for the sale of Western Washington State College Housing and Dining System Bonds of 1968 were publicly opened and read by him in Room 131 of the Education Building on the campus of the College, immediately after 3:00 p.m. Pacific Daylight Saving Time, on August 8, 1968.

He also reported that he had tabulated the bids and he submitted the tabulation together with the original bids to the Board, which examined and considered them. Thereupon, Resolution No. 68-7 captioned as follows was presented to the Board:

The motion was made by Mr. Kingsbury, seconded by Mr. Philbrick and passed unanimously that Resolution No. 68-8 be adopted.

The low bid of John Nuveen & Company, Chicago, and the Seattle-First National Bank at an interest rate of 4.8294 was accepted by the Board.

67-17 HIDDEN VALLEY, PHASE II (HOUSING 1970) Preliminary Plan presentation - Royal McClure

Mr. Robert Aegerter, College Architect, and Mr. Royal McClure, Project Architect, presented to the Board preliminary plans for Hidden Valley, Phase II (Housing 1970). Mr. Kingsbury moved that upon the recommendation of the administration, the Board of Trustees accept the design development phase proposed by Project Architect Royal McClure, and authorize the architect to proceed with working drawings, subject to further budgetary analysis and administrative approval prior to August 21, 1968. Mr. Philbrick seconded the motion; the motion passed.

67-10 PHYSICAL PLANT BUILDING BIDS

Mr. Goltz reported that the bids received on this project were above the estimates; the apparent low bidder was J. R. Dawson Company at \$477,300. No recommendation is to be made at this time because of the cost involved. He reported that the project will probably be rebid.

DEVELOPMENT OF PARKING AREA IN FRONT OF FAIRHAVEN HALL

Mr. Goltz asked for approval from the Board for the development of approximately ten parking spaces in front of Fairhaven Hall. Mr. Kingsbury moved approval of the development; Mr. Philbrick seconded the motion; the motion passed.

ACTION ON CONFIRMATION OF RESOLUTION NO. 68-8
