MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES WESTERN WASHINGTON STATE COLLEGE January 13, 1966

A regular meeting of the Board of Trustees of Western Washington State College was held beginning at 4:30 p.m. in Room 131 of the Education Building. Present were Mr. Joseph Pemberton, Mr. Marshall Forrest, Mr. Burton Kingsbury, Mrs. Bernice Hall, and President Harvey C. Bunke. Also present were Mr. Joe Nusbaum, Business Manager, Mr. Paul Coughlin and Mr. Rolla Houghton, bond counsel, and Mr. James Frazer, financial consultant.

CONSIDERATION OF BIDS AND RECOMMENDATION OF THE BUSINESS MANAGER REGARDING SALE OF WESTERN WASHINGTON STATE COLLEGE HOUSING AND DINING SYSTEM BONDS OF 1965, IN THE PRINCIPAL SUM OF \$8,249,000.

Mr. Nusbaum reported that all of the bids received for the sale of Western Washington State College Housing and Dining System Bonds of 1965 were publicly opened and read by him in Room 208, Viking Union Building, immediately after 1:00 p.m., Pacific Standard Time, January 13, 1966, and the bids tabulated by him; that the only bids received were those of the U. S. Government for the Series B through Series F bonds at the previously agreed upon interest rate and the Pacific Northwest Company and Blyth & Co., Inc. for Series A bonds at an interest rate of 4-3/4%. Mr. Nusbaum reported that later in the afternoon after discussions between their representative and Mr. Frazer, Pacific Northwest Company and Blyth & Co., Inc. submitted a revised bid for the purchase of the Series A bonds at an interest rate of 4-1/2%, subject to the making of a change in the basic bond resolution to provide for 1.25 coverage. Both the original bid and the revised bid of Pacific Northwest Company and Blyth & Co., Inc. also provided for a small premium on the bonds.

Mr. Frazer discussed the financial aspects of the bids received. He recommended acceptance of the revised bid for the Series A bonds and the bid of the Government for the Series B through Series F bonds. Mr. Coughlin discussed the legal aspects of the various resolutions proposed for Board action. He explained that the condition attached to the bid on Series A requires a change in the bond resolution which would commit the College to maintain a level of net revenues equal to 1.25 times the average annual debt service. Mr. Nusbaum and Mr. Frazer indicated this change would not create a problem for the College.

Mrs. Hall moved the adoption of Resolution No. 66-1 (a copy of which is attached to the official minutes), accepting the revised bid of Pacific Northwest Company and Blyth & Co., Inc. for Series A and the bid of the Government for Series B through Series F; Mr. Forrest seconded the motion; the motion passed unanimously.

Mr. Forrest moved the adoption of Resolution No. 66-2 (a copy of which is attached to the official minutes), modifying the bond resolution to require a coverage of net revenues of 1.25 times the average annual debt service; Mr. Kingsbury seconded the motion; the motion passed unanimously.

Mr. Kingsbury moved the adoption of Resolution No. 66-3 (a copy of which is attached to the official minutes) which calls the Western Washington College of Education dormitory and revenue bonds of 1955 and 1956; Mrs. Hall seconded the motion; the motion passed unanimously.

The meeting adjourned at 5:40 p.m.

RESOLUTION NO. 66-1

A RESOLUTION of the Board of Trustees of Western Washington State College accepting bids for the purchase of Western Washington State College Housing and Dining System Bonds of 1965 in the principal sum of \$8,249,000.

WHEREAS, on December 17, 1965 this Board adopted a resolution entitled

"A RESOLUTION of the Board of Trustees of Western Washington State College establishing the Western Washington State College Housing and Dining System, authorizing Western Washington State College Housing and Dining System Bonds, authorizing the issuance and sale of Western Washington State College Housing and Dining System Bonds of 1965 in the principal sum of \$8,249,000 and providing for the date, form, covenants, terms and maturities thereof."

hereinafter called the Bond Resolution, in which it was provided that the bonds therein described should be sold at public sale and that sealed bids therefor would be received at Room 208, Viking Union Building, on the campus of the College in Bellingham, Washington, until 1:00 o'clock P.M., Pacific Standard Time, on January 13, 1966, at which time such bids would be publicly opened, and

WHEREAS, on the same date this Board adopted a resolution entitled

"A RESOLUTION of the Board of Trustees of Western Washington State College Relating to the Notice of Sale and Official Statement for Western Washington State College Housing and Dining System Bonds of 1965."

wherein provision was made for publication of notice of sale of said bonds and for the issuance and distribution of an Official Statement concerning the bonds, and WHEREAS, notices of sale prepared by the Business
Manager of the College were published in The Daily Bond Buyer,
a financial newspaper of national circulation published in
New York, New York, and in The Daily Journal of Commerce, a
legal newspaper published in Seattle, Washington, and

WHEREAS, all of the bids received at the place and at or prior to the time specified were publicly opened at the time and place specified, a tabulation of them being set out on Exhibit A annexed hereto, and

WHEREAS, after the opening of the bids Pacific Northwest Company - Blyth & Co., Inc., the sole bidder for the Series A Bonds, modified its original bid and presented a bid in the form set out on Exhibit B annexed hereto, and this Board after due consideration has determined that it is to the best interest of the College that such modified bid be accepted, and

WHEREAS, for the Series B through Series F Bonds the only bid received was the bid of United States of America, Department of Housing and Urban Development, which offered to purchase the Series B through Series F Bonds at prices specified in the loan agreement previously entered into between the College and the Department of Housing and Urban Development, and it being in the best interest of the College that such bid for the Series B through Series F Bonds be accepted,

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Western Washington State College:

Section 1. The modified bid of Pacific Northwest
Company - Blyth & Co., Inc., for the purchase of \$500,000 par
value Western Washington State College Housing and Dining System
Bonds of 1965, Series A, at the price of \$100.003 per \$100
principal thereof plus accrued interest from October 1, 1965
to the date of delivery of the bonds to the purchaser is hereby accepted, with the understanding that the aforesaid Bond
Resolution adopted December 17, 1965 will be amended to provide
the coverage covenant of 1.25 mentioned in the modified bid and
said Series A Bonds are awarded to said bidder and shall be
delivered to it upon payment of the total purchase price of
\$500,015 plus accrued interest to the date of delivery in conformity with its bid.

Section 2. Series A Bonds will bear interest at the rate of 4-1/2% per annum.

Section 3. The bid of the United States of America, Department of Housing and Urban Development, for the purchase of Western Washington State College Housing and Dining System Bonds of 1965, Series B, C, D, E and F at the price of \$100 per \$100 principal thereof, plus accrued interest from October 1, 1965 to the date of delivery of the bonds, is hereby accepted and said bonds are awarded to said bidder. At such time as the Government shall designate the Series F Bonds shall be delivered to it upon payment of their total purchase price of \$2,350,000 plus accrued interest to the date of delivery in conformity with its bid. At the time of the delivery of the Series F Bonds to the Government, the Series B through Series E Bonds in the following amounts shall be exchanged respectively with the Government

for like principal amounts of the following outstanding bonds of the College:

Series B	\$ 384,000	Western Washington College of Education Student Center Revenue Bonds of 1957
Series C	\$1,805,000	Western Washington College of Education Dormitory and Dining Hall Revenue Bonds of 1959
Series D	\$1,750,000	Western Washington State College Dormitory Revenue Bonds of 1961
Series E	\$1,460,000	Western Washington State College Dormitory and Dining Hall Revenue Bonds of 1961

In accordance with the loan agreement between the College and the Government, payment of accrued interest on the bonds to be surrendered by the Government and the bonds to be delivered to it in exchange therefor shall be adjusted so that no overlapping interest is paid and any balance of accrued interest due on the bonds so surrendered by the Government shall be paid to the Government forthwith upon surrender.

PROVIDED, HOWEVER, the sale and delivery to the United States of America of the Series B, Series C, Series D, Series E and Series F Bonds is contingent upon the satisfactory prior or concurrent completion of the sale and delivery and receipt of the purchase price of the Series A Bonds.

Section 4. The Series B through Series F Bonds shall bear interest at the following rates: Series B, 2-7/8%; Series C, 3-1/8%; Series D, 3-1/2%; Series E, 3-1/2%; Series F, 3-5/8%.

Section 5. The forms of notice of sale prepared by the Business Manager for publication and the publications thereof made in The Daily Bond Buyer and The Daily Journal of Commerce are hereby ratified and approved.

Section 6. The proper officers of the College and its Board of Trustees are hereby authorized and directed to do all things necessary for the prompt execution, issuance and delivery of said bonds to the purchasers thereof in accordance with the terms of their bids and this resolution and for the prompt application and use of the proceeds of the sale.

A RESOLUTION Relating to Western Washington State College Housing and Dining System Bonds of 1965 and amending the Bond Resolution with respect thereto.

WHEREAS, on December 17, 1965 this Board adopted a resolution entitled

"A RESOLUTION of the Board of Trustees of Western Washington State College establishing the Western Washington State College Housing and Dining System, authorizing Western Washington State College Housing and Dining System Bonds, authorizing the issuance and sale of Western Washington State College Housing and Dining System Bonds of 1965 in the principal sum of \$8,249,000 and providing for the date, form, covenants, terms and maturities thereof.", and

WHEREAS, it is now deemed desirable to amend this resolution in the respect hereinafter provided,

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Western Washington State College:

Section 1. Subsection A of Section 15 of said resolution is hereby amended to read as follows:

A. The College will establish, maintain and collect rentals, fees, charges and other income derived through the ownership, operation, occupancy and use of the lands, buildings and facilities constituting the System which, together with special student fees levied against each full-time student which shall be established at an initial rate of \$25.00 per academic quarter and against each part-time student which shall be established at an initial rate of \$5.00 per academic quarter, shall be adequate to provide revenues sufficient for the payment of the principal of and interest on the Bonds and all payments which the College is obligated to set aside in the Sinking Fund Account (including the Debt Service Reserves therein) and the System Repairs Reserve, and for the proper operation and maintenance

of the System and for payment of all necessary current maintenance charges and expenses of reasonable upkeep and repairs: Provided, That so long as any of the principal of or interest on the Bonds remains unpaid, such rentals, fees, charges, income and special student fees shall be established and maintained and collected in amounts sufficient to provide annual net revenues (meaning gross revenues of the System and revenues from the pledged special student fees less current expenses of the System) equal to at least one and twenty-five hundredths (1.25) times the combined average annual requirements for principal and interest on the System Bonds outstanding.
