#### **CALL TO ORDER**

### 1. EXECUTIVE SESSION

State law authorizes colleges and universities to engage in collective bargaining with classified staff. The law sets forth several deadlines, one of which is October 1, 2004, for agreements regarding all economic matters that may require or impact legislative appropriation.

At 10:12 a.m. the Board returned to open meeting and took the following action:

MOTION 9-1-2004

Betty Woods moved that the Board of Trustees of Western Washington University hereby approve the following proposed collective bargaining agreements:

- Washington Federation of State Employees Council #28 of the American Federation of Sate, County and Municipal Employees AFL/CIO Bargaining Unit "A".
- Washington Federation of State Employees Council #28 of the American Federation of State, County and Municipal Employees AFL/CIO Bargaining Unit "B".
- Washington Public Employees Association / United Food and Commercial Workers Union Local #365, Bargaining Unit "C".
- Washington Federation of State Employees Council #28 of the American Federation of State, County and Municipal Employees AFL/CIO Bargaining Unit "E".

Further, that the Board of Trustees authorizes the president or her designee to execute the agreements on behalf of the Board effective September 30, 2004, in keeping with its reserved authority in the *WWU Board of Trustees Rules of Operation*, Section 020(3)(h).

The motion passed unanimously.

MOTION 9-2-2004

Betty Woods moved that the Board of Trustees of Western Washington University approve the proposed economic agreement with the Public School Employees of Washington, Bargaining Unit "D". Further, that the Board of Trustees authorizes the president or her designee to execute the agreements on behalf of the Board effective September 30, 2004, in keeping with its reserved authority in the *WWU Board of Trustees Rules of Operation*, Section 020(3)(h).

The motion passed unanimously.
