

MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES

May 22, 1942.

The regular meeting of the Board of Trustees was held on Friday, May 22, 1942, at 3:30 P. M. in the President's office. Those present were Dr. W. D. Kirkpatrick, Chairman, Mr. Verne Branigin, Secretary, Mr. Steve Saunders, and President W. W. Haggard. The minutes of the previous meeting were read and approved.

COMPLETION OF CAMPUS ELEMENTARY SCHOOL BUILDING

John Paul Jones, Architect, reported that the Campus Elementary School building had now been completed except for odds and ends. Regarding the heating pipes underneath the kindergarten, and first and second grade units that have corroded, Mr. Jones stated that a solution would be recommended at the earliest possible date. It was agreed to contract for the levelling of the frontage around the building, that black dirt for terraces be purchased, and a temporary walk laid.

HOGGED FUEL RECOMMENDED

John Paul Jones recommended that the use of hogged fuel in the heating plant be continued, in preference to changing to the use of other fuel.

WAR PRODUCTION BOARD MAY REQUISITION BOILERS

John Paul Jones reported that C. C. Moore & Company, Engineers, informed him recently that the new boilers now stored near the heating plant may be requisitioned by the War Production Board.

STUDENT FEES INCREASED FOR 1942-1943

Increases in student fees for 1942-43 were approved as follows:

Health Fee to be increased from two (\$2.00) dollars a quarter to two (\$2.50) dollars and fifty cents a quarter.

Klipsun Fee to be increased from one (\$1.00) dollar a quarter to one dollar and (\$1.50) fifty cents a quarter.

FROPERTIES FOR SALE

The property at the junction of 21st Street and Sehome Drive, owned by Edna J. Hollister, may be purchased for twelve hundred (\$1200.00) dollars. Smith, Livesey & Wright, Realtors, are investigating the possibility of our acquiring the property on High Street between the tennis courts and Cedar Street. Mr. Percy Livesey is of the opinion that this property can be obtained at a price that would not be excessive.

REQUEST FOR RELEASE OF FUNDS FOR REPAIRS

The President was instructed to request Governor Langlie for the release of fourteen hundred (\$1400.00) dollars for repairs to be made to the gymnasium at the rear of the Main Building, and the prenursing education laboratory, from our appropriation of \$6000.00 for Repairs, Buildings, and Equipment, Chapter 234, Laws of 1941.

LEAVES OF ABSENCE FOR FACULTY CALLED TO SERVICE IN U. S. ARMED FORCES

The following resolution was passed regarding the contractual status of members of the faculty called to service in the armed forces of the United States:

DE IT RESOLVED, That members of the faculty upon call to war service be granted leaves of absence, provided that the individuals on leave keep the administration informed of plans for return to civilian life, if known; and that resumption of service at the College be at the beginning of an academic year, unless other arrangements can be made with substitutes employed during the absence of regular members of the faculty.



APPLICATION FOR APPROVAL BY AMERICAN ASSOCIATION OF UNIVERSITY WOMEN

It was agreed that formal application be sent to the Secretary of the Committee on Membership and Maintaining Standards of the American Association of University Women, Washington, D. C., for approval of Western Washington College of Education, which, if granted, will allow the graduates of the College holding the degree of bachelor of arts in education the privilege of membership in the American Association of University Women.

RESIGNATION OF MARY OSSINGER

The resignation of Mary Ossinger, instructor in prenursing education, was accepted as of September 30, 1942. The President reported that he is finding it difficult to secure an instructor to fill the position on the faculty which Mrs. Ossinger's resignation leaves vacant.

APPOINTMENT OF ALAN ROSS

The appointment was approved of Alan Ross, A. M., Yale University, at a salary of twenty-four hundred (\$2400.00) dollars a year beginning September 14, 1942, to succeed Dr. Paul R. Grim in the Campus Junior High School, Social Studies.

RETIREMENT OF MRS. A. C. JACKSON

Postponement for two years, until 1944, of the retirement of Mrs. A. C. Jackson, janitress, was discussed. Mrs. Jackson has now passed the age for retirement. She has been in the employ of the College for nineteen (19) years, since 1923; and in the employ of the State of Washington for twenty-eight (28) years, having taught in the public schools of the state prior to her employment here in 1923. In order to receive the full \$40 a month at retirement from the State Teachers Retirement Fund, thirty years of service are required. For this reason Mrs. Jackson requests the postponement of her retirement for two years; when she will have completed the required thirty years of service in the state. No decision was reached in this matter.

INCREMENTS IN SALARIES

Increments were approved in salaries, as of April 1, 1942, of \$100.00 each for twenty-seven (27) members of the staff, and one of \$140.00, totalling twenty-eight hundred and forty (\$2840.00) dollars, as follows:
