# MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES May 13, 1965

The regular meeting of the Board of Trustees of Western Washington State College was held Thursday, May 13, at 5:30 p.m. in Room 215 of Haggard Hall. Present were Mr. Joseph Pemberton, Mr. Marshall Forrest, Mrs. Bernice Hall, Mr. Stephen Chase, Mr. David Sprague, President Harvey C. Bunke, and Mr. Harold Goltz, Assistant to the President.

PRESENTATION OF A GIFT TO THE COLLEGE BY MRS. ALMA OSTROM

Mrs. Alma Ostrom of Everson, Washington, presented a check in the amount of \$10,000 to Mr. Pemberton to establish a "Peter and Alma Ostrom Library Memorial Fund" to be used primarily for the establishment and continuation of a library collection to be known as the "Ostrom Social Science Collection." Mr. Forrest moved adoption of the following resolution:

The Board of Trustees of Western Washington State College gratefully accepts the gift of the "Peter and Alma Ostrom Library Memorial Fund" generously made by Alma Ostrom and further accepts the conditions related thereto in accordance with the agreement dated May 13, 1965, and authorizes Mr. Joseph Pemberton to accept the gift on behalf of the college, and provides that the \$10,000 is to be deposited to the Consolidated Endowment Fund of the college.

Mrs. Hall seconded the motion; the motion passed.

The Board expressed deep gratitude to Mrs. Ostrom for her gift.
